WHEREAS, ASNT Certification Services, LLC is engaged in conducting personnel qualification and certification services, and, in such activities, administers examinations worldwide.

WHEREAS, ASNT Certification Services, LLC reviews and administers examinations that contain information that is confidential and is the private property of ASNT or ASNT Certification Services, LLC.

WHEREAS, you desire to accept an appointment to serve as a volunteer member of the Certification Management Committee ("CMC"). NOW THEREFORE, in consideration for the opportunity to serve the ASNT Certification Services, LLC as a volunteer member of the CMC, I understand and agree to be legally bound by this Agreement. ASNT Certification Services, LLC will not (and would not) have me serve as a CMC volunteer unless I execute and agree to abide by the terms of this Agreement, the Parties agree as follows:

1. <u>CONFIDENTIAL INFORMATION</u>. The term "Confidential Information" means any and all non-public, confidential or proprietary information or material which is proprietary to ASNT or ASNT Certification Services, LLC, whether or not owned or developed by ASNT or ASNT Certification Services, LLC, and which may be obtained through any direct or indirect contact with ASNT or ASNT Certification Services, LLC.

Confidential Information may include but is not limited to data or materials, whether written or otherwise, shared by ASNT or ASNT Certification Services, LLC including, but not limited to, information regarding analysis, memoranda, e-mail messages, voice mail messages, notes, correspondence, research, materials, products, technology, programs, business plans, marketing plans, financial information, trademarks, policies, prospects and future plans, and other information disclosed or submitted, orally, in writing, or by any other media. You recognize that ASNT or ASNT Certification Services, LLC has and will have the following Confidential Information, any and all of which may be furnished to you:

and other items of proprietary information (collectively included as part "Confidential Information") which are valuable, special and unique assets of ASNT or ASNT Certification Services, LLC.

You agree that you will not at any time or in any manner, either directly or indirectly, use the Confidential Information disclosed to you for your own benefit, or divulge, disclose, or communicate in any manner the Confidential Information to any third party. You shall use Confidential Information only in furtherance of the purpose of this Agreement. You agree to comply with the rules and directions associated with this Confidential Information including those relating to confidentiality and to independence from commercial and other interests, and from any prior and/or present link with the persons to be examined that would compromise impartiality.

2. **OWNERSHIP.** All Confidential Information and all other information, and all derivatives thereof are and shall remain, at all times, the sole and exclusive property of ASNT or ASNT Certification Services, LLC. You shall acquire no rights thereto, other than the limited right to use such Confidential Information and other information as necessary to perform their obligations as outlined in this Agreement or other CMC policies and procedures.

Upon the first written request of ASNT or ASNT Certification Services, LLC, you shall promptly return to ASNT or ASNT Certification Services, LLC all copies of all documents which were, at any time, in your possession and all materials (in any medium), which contain or embody the Confidential Information.

3. CONFLICT OF INTEREST. You agree to notify ASNT Certification Services, LLC upon determination or suspicion that you may have a conflict of interest related to your activities between the interests of ASNT Certification Services, LLC, and other interests that you may have so that ASNT Certification Services, LLC can undertake measures to ensure that confidentiality and impartiality of the examination process is not compromised. Providing training courses specifically designed to prepare individuals for the ASNT Certification Services, LLC certification examinations is perceived as a conflict of interest for CMC Members. CMC Members are expected not to engage in preparatory or refresher training specifically for ASNT Certification Services, LLC administered third-party examinations. As such, while you may provide full course training in a method or radiation safety, you are prohibited from mentioning or hinting at the content of ASNT Certification Services, LLC examinations during such training.

In the case of uncertainty, the CMC Chair shall be notified of any potential conflict of interest. Furthermore, due to the ASNT Certification Services, LLC Level III Code of Ethics, any Confidential Information gained on the CMC shall not be used for a period of ten (10) years or until the Confidential Information for preparatory or refresher training becomes a part of the public domain, whichever occurs first.

4. COMMITMENT TO COMPLIANCE. You agree to commit yourself to put forth your best efforts to comply with the rules relating to your activities for ASNT or ASNT Certification Services, LLC and the provisions of the Agreement contained herein, and specifically those rules relating to the examination process, including those relating to confidentiality and those relating to independence from outside commercial and other interest, and from any prior and/or present link with persons to be examined that would compromise impartiality. You understand and agree that this Agreement does not create a contractual right for you to serve as a volunteer of the CMC and your service may be suspended or terminated by ASNT Certification Services, LLC at any time and for any reason.

- SUCCESSORS AND ASSIGNS. This Agreement shall be binding on the Parties, and on their successors
  and assigns, without regard to whether it is expressly acknowledged in any instrument of succession or
  assignment.
- 6. <u>CONFIDENTIALITY AFTER TERMINATION</u>. The confidentiality provisions of this Agreement shall remain in full force and effect after the termination of this Agreement for a period of ten (10) years or until the Confidential Information becomes a part of the public domain, whichever occurs first.
- 7. **GOVERNING LAW.** This Agreement shall be governed in all respects, except as to conflicts of laws, by the laws of the State of Ohio and the parties' consent to the jurisdiction (both subject matter and personal) of the State of Ohio and acknowledge that it is the appropriate venue for any such dispute resolution.
- 8. I understand and agree that money damages may not be a sufficient remedy for any breach of this Agreement and that ASNT Certification Services, LLC shall be entitled to equitable relief, including but not limited to a temporary restraining order, and preliminary and permanent injunctions, for breach of this Agreement. Such remedies shall not be deemed the exclusive remedy for breach of the Agreement but shall be in addition to all the remedies available at law or in equity. In addition, ASNT Certification Services, LLC shall be entitled to recover from me all costs and expenses incurred by ASNT Certification Services, LLC in enforcing the Agreement, including, without limitation, attorneys' fees and court costs.
- 9. **ASSIGNMENT OF COPYRIGHT.** For good and valuable consideration, receipt of which

- 1.1.2. Have experience in administering and auditing NDT programs.
- 1.1.3. Provide a letter of support from their employer agreeing to support the member's required attendance at four (4) meetings per year and 2 (2-day) work sessions along with allowing reasonable time to complete assignments between meetings. If a member changes employers during their term on the CMC, a new employer support letter will need to be provided within 60 days of their hire date with the new employer.

#### ASSOCIATE MEMBERSHIP

- 1.1.1. Have at least seven (7) years of experience in NDT or Predictive Maintenance (PdM) and shall possess a current ASNT NDT Level III Certificate and have performed as a Level III for at least the past two (2) years at the time their application is considered.
- 1.1.2. Have experience in administering and auditing NDT programs.
- 1.1.3. Provide a letter of support from their employer agreeing to support the member's required attendance at two (2) meetings per year and one (1) of those meetings being either the summer or winter and 1 (2-day) work session along with allowing reasonable time to complete assignments between meetings.
